
As you know, New Criminal Rule 8.5(c) states that we must provide a Jail Census no later than seven (7) days before the commencement of each term of Circuit Court to the presiding judge, the District Attorney and the Clerk of the Circuit Court. This census must include the name of all defendants in the County's custody, the charges for which they are being held, and the date that they were most recently taken into custody.

If you can forward me your March Jail Census, I can keep MacArthur from suing us.


